## **RENTAL AGREEMENT**

**Agreement to Rent** - SATELLITE PHONE SOURCE, LLC agrees to rent to Customer the phones, and all accessories as agreed in this Agreement. The Term of this Agreement is determined from the dates the customer first receives the phone and ends when SATELLITE PHONE SOURCE, LLC receives such equipment back in full.

**Rental Charges** - Customer agrees to for the rental of all equipment, shipping, airtime and taxes incurred from the rental and use of the equipment and services in this Agreement. Additional rental charges of \$10 per day will be incurred on all equipment not returned by the date on page 2 of this Agreement. If any equipment is found to be damaged when returned then such equipment would be charged to customer at cost of replacement.

**Warranty** - We guarantee that the phone will be in good working condition upon receiving the equipment. The customer must test all phones rented by making a test call to SATELLITE PHONE SOURCE, LLC customer service. If such test call is not made then SATELLITE PHONE SOURCE, LLC will not be responsible for faulty equipment. SATELLITE PHONE SOURCE, LLC DOES NOT guarantee airtime service at any time as there are many factors that may keep the phone from working at any time and we cannot service for any Iridium, Globalstar or Inmarsat service as we have no control over these satellite networks.

**Limitation of Liability** - In no event will SATELLITE PHONE SOURCE, LLC, be liable to the Customer for any incident, indirect or consequential damages however caused, whether by SATELLITE PHONE SOURCE, LLC, negligence or otherwise.

**Indemnity** - The Customer agrees to protect, indemnify and hold harmless SATELLITE PHONE SOURCE, LLC, from and against all claims, damages and costs including legal expenses arising out of the Customer's use of this Equipment.
